 - **a) Ref: 1565/19/FUL Proposal:** Provision of an agricultural storage building **Location:** Ocean View Farm, Raddicombe Drive, Hillhead, TQ5 0EX
 - b) Ref: 1889/19/TPO Proposal: T1: Beech Reduce the lower limbs to the North of the tree extending towards the gardens of Brookhill by between 2m and 1m to leave crown with a good form; T2: Eucalyptus Crown reduction by 4 metres; G1: 15x Sycamore, 5x Oak, 5x Elm, 5x Holly Cyclical permission to re-pollard the trees when the re-growth extends beyond 2 metres; G2: Holm Oak, Laurel, English Oak, Pittosporum Cyclical permission to prune back from building to maintain a 2 metre clearance Location: Flat 8 Brookhill, Castle Road, Kingswear, TQ6 0DX
 - c) Ref: 1912/19/TPO Proposal: G1: 2x Monterey Cypress Dismantle and fell to near ground level; T1:Holm Oak Reduce 3x secondary branches by no more than 3m from tip to suitable growth point to achieve 1m clearance from garage roof/fascia;T2: Sweet Chestnut remove 1x over-extended dead branch at approximately 11m; T3: Holm Oak Crown lift by removing 7 small primary branches and reduce over-extended branch back in line with canopy over higher drive/access road; T4: Pittosporum Dismantle and cut down to approximately 1m above ground level to create a trimmable shrub for the future; T5: Holm Oak Remove lowest primary branch growing over driveway and trim growth back to wall over access road Location: 4 Kingswear Court, Castle Road, Kingswear, TO6 0DX
 - **d) Ref: 2202/19/VAR Proposal:** Variation of condition 2 (approved plans) of planning consent 1778/18/FUL (Replacement of existing dwelling and construction of a new dwelling on site of existing garage) **Location:** Tanglewood, Higher Contour Road, Kingswear, TQ6 0DE
 - **e) Ref: 2084/19/TCA Proposal:** T1 Eucalyptus Dismantle and fell to near ground level, treat stump with eco plugs to prevent re-growth; The tree is starting to over dominate the garden **Location:** Kingscliffe, Beacon Lane, Kingswear, TQ6 0BU
