- 5. To consider any additional funding to be included in the budget 2018/2019 for the provision of grants to local organizations.
- 6. To consider the draft budget figures as per the attached and make any other amendments considered necessary. See notes below.
- 7. To agree the final Precept figure for 2018/2019.
- 8. To approve the continued appointment of Kevin Rose ACMA as the Council Internal Auditor.

The calculated precept figure for 2018/2019 has increased from £24299 to £33174 an increase of £8875 or 36.5%

The last two years budgets have been affected by the income and expenditure associated with the Play Equipment and Cemetery receipts:

2016/2017	Cemetery income	£11405
2018/2019	Budget for this year	£2500

The inclusion of M Emms Bequest during 2016/2017 resulted in the surplus of £22175.

The Budget calculation for 2017/2018 allowed the Precept to remain at the previous year figure and as you will see from the interim report 31.12.17 Page 6 there is currently a surplus of £7452 and additional income to come from the Moorings. On this basis the outcome is forecast to be near to break even.

The Council has  $\pounds65000$  in reserves which is  $\pounds35000$  in excess of the recommended figure of the annual Precept. Excluding  $\pounds17000$  M Emms Bequest (if to be set aside) the Council has the potential option to use  $\pounds18000$  to set against the Precept figure for the forthcoming year.

The forecast costs and income are not going to change (assuming status quo) therefore, in the light of falling cemetery income (which is an item that should never be relied upon in the long term), increasing costs the Council will need to implement a programme of increasing Precepts over the forthcoming years.

## Proposal:

The Council reduces the final Precept figure by £5000 over the next 3 years to implement a staggered budget increase and a reduction of the reserve surplus.
